FROM THE REGISTRAR

It has been some time now since the last newsletter but there has been much activity behind the scenes. Our last newsletter discussed the activity of the Accreditation Board in developing and promoting capability as part of the Australian WHS Strategy 2012-22. Capability is more than competence; it requires underpinning theoretical knowledge together with industry specific knowledge and practical experience. The OHS Body of Knowledge for Generalist OHS Professionals describes this theoretical knowledge and is gaining recognition in Australia and internationally. With the support of Safe Work Australia we have developed four new chapters for the OHS Body of Knowledge. Also, the Accreditation Board has been working with the universities and four further programs are now accredited with other universities working on developing their programs and their applications for accreditation. New developments for the OHS Body of Knowledge

While the Safety Institute of Australian holds the copyright for the OHS Body of Knowledge for Generalist OHS Professionals this license is conditional that the SIA promotes the OHSBoK, supports its dissemination and maintains its currency. In its role as 'custodian' maintaining the currency and further development of the OHSBoK is the responsibility of the Accreditation Board.

With the support of Safe Work Australia, the Accreditation Board has been working with others to develop four new chapters for the OHS Body of Knowledge. A Topic Specific Technical Panel was convened for each chapter. These technical panels developed the scope of the chapter and, in some cases, authored the chapters. Each chapter has a section on implications for practice; in some cases this section has been written by an OHS professional, in others a workshop has been used to identify the implications for practice. These new chapters of the OHS Body of Knowledge were launched on the 29th October as part of Safe Work Month.

The chapter on A *user centred, safe design approach to control* has been developed in association with the Human Factors and Ergonomics Society of Australia (HFESA). The chapter emphasises the importance a framework of participatory ergonomics and considers the roles that generalist OHS professionals can take in the workplace design and control process. The chapter provides an example of a user-centred safe design tool.

Written by some of our leading OHS lawyers, the chapter *Principles of OHS law* is <u>not</u> OHS Law 101 but an insightful distillation of the principles of law and the fundamentals of how to apply the principles of case law to OHS in the workplace. An understanding of these principles will allow OHS professionals to develop an approach to compliance that is sensitive to the specific circumstances and leads to optimal OHS outcomes.

Organisational culture is a challenging topic and is a ground breaking chapter for the OHS BoK. Dr David Borys has undertaken a literature review, interviewed Australian and international academics and OHS professionals, and conducted two focus groups as part of developing the chapter content.

The OHS risk and decision making chapter is being written in association with the Minerals Industry Safety and Health Centre (MISHC) at the University of Queensland. Informed by a workshop attended by leading OHS academics working in risk and decision making and OHS professionals, this chapter brings together current thinking on risk and decision making and challenges some common held beliefs and practices.
